CALL TO ORDER- Mayor Ric Bogue called the meeting to order at 6:30 PM

INVOCATION & PLEDGE OF ALLEGIANCE-

ROLL CALL- Catherine Long called attendance.

-All Council Members were present; Council Member Roland Agrella was absent.

UNSCHEDULED VISITORS & COMMENTS -

The new owners of what used to be Smith's Nursery, ACI Greenhouse was present, they were supposed to be a line item on the agenda, however, they were left off by mistake. They stated that they bought Smith's Nursery, and they will continue to run it as a wholesale nursery, however, they would like to add a retail part to the business and sale plants and trees. Mayor Bogue stated that the Council could not officially vote on it, that it would have to be table until March. However, Council stated that they do not have an issue with the request.

Mr. Derrick stated that he intends to repair and remodel the home. He is meeting with a contractor to get the work started. He had intended to do the work himself, however he is just to busy. The council stated that the windows should be boarded up and the doors secured until the work starts. Mr. Derrick stated that he would get the windows boarded up. He asked what the process is to start the repair/remodel. Mayor Bogue stated that he would need an inspection before starting any work, and for him to get with City Secretary, Catherine Long to get the process started.

REGULAR AGENDA

<u>NEW BUSINESS</u> – Discussion and Possible Action may be taken on the following:

a. Katherine Bacon – Requesting to place a manufactured home at 2106 4th Street.

Ms. Bacon was not present.

- b. Jay Lotiff Requesting to add water meters to half of his manufactured home park, located at 7431 CR 171. Wants to put in 13 meters and then add more later.

Mr. Lotiff stated that he has a septic for one side of the park, but needs to get a septic for the other side. He is planning on doing away with an RVs in the park and strictly do manufactured homes. He wanted to get approval to run water lines and install meters for one side of the park, and then have the other side done at a later date. Brandon Middleton told him that he needed to go to Drainage #3 first and have a pre-construction meeting with them before anything could be done. Mayor Bogue told Mr. Lotiff that once he meets with Drainage to come back and it would be discussed.

-Council Member Marie Middleton made a motion to table the possibility of putting in meters to half the park until March.

c. Gale and Paul Froberg – Requesting possibly opening an agricultural/Feed Store or Restaurant .

Mrs. Froberg presented the Council with a proposal of opening a feed store and/or a restaurant. She stated that they would sale a type of feed that is not sold around this area. She also stated that it would be high end restaurant as well. Mayor Bogue asked where they wanted to put the business. Mrs. Froberg stated that they were looking at the house at 8518 Calhoun Street (CR 171). The council stated that without a set plan and location they would not vote on approving it. But they were not opposed to the idea. Mayor Bogue stated that they needed to get it planned out better and then come back in March.

- d. Resolution 2025-A becoming a member of TML'S BuyBoard

City Secretary stated that the City is a member of TML, however, not a member of the BuyBoard. She explained that the BuyBoard is a place where Cities, Schools and Government Entities could buy merchandise, such as ATV's all the way to office furniture, at a discounted rate.

- e. Calibration of well meters.

City Secretary Catherine Long, stated that the calibrations needed to be done by Mercer. Mayor Bogue stated that it was necessary for them to work properly.

- f. Repair and certification of gauges for the Arsenic unit.

City Secretary, Catherine Long stated that the gauges are not working and need to be repaired. And that the City has quote from Fluid Meters in the amount of \$3700.00.

OLD BUSINESS –Discussion and possible action may be taken on the following items:

a.. Riverhaven dedicated roadway

City Secretary, Catherine Long stated that Mr. Ricketts came in and signed the agreement, then came in the next day and stated that his Attorney told him not to sign in. However, it was already signed and done.

b. Building Security - Bollards in parking lot and fence around ac units and electrical panel

The Council looked at three quotes, just for the bollards, not the fence. The quotes were from Haynes Services & Construction in the amount of \$2260.00; C.Link in the amount of \$2600.00; and Hog Construction Services in the amount of \$2500.00 for concrete outdoor planters, and \$4000.00 for bollards.

- c. City Limit Signs

The Council looked at four quotes for the 4 "Welcome to Liverpool" city limit signs. The quotes were from Signfly in the amount of \$2263.12; RCL Signs LLC, in the amount of \$2064.00 (for 3 signs); Led Lights and Signs in the amount of \$1271.94 (for 1 sign, would be a total of \$5087.76); and Bauer Visual Graphis, Inc in the amount of \$4038.46.

- d. Jonas Duncan Request to subdivide 1 acre from 5 acres of property located at 16511 CR 191 Unit C.

Mr. Duncan stated that he was wanting to buy the 1-acre lot from Joan Bennett Bell, whom was also present. Therefore, wanted to request that the 5 acres be subdivided into 1 1-acre lot and a 4-acre lot.

- f. A/C unit for Water Plant Building and Arsenic Unit.

Brandon Middleton stated that he spoke with Evan and that he needed to get the sq. footage of the buildings and that he would send City Secretary, Catherine Long, the link to the mini split units that needs to be bought. He is going to find out from Evan if the unit in the Arsenic Unit needs to have heat on it as well.

-Motion was made by Marie Middleton to purchase 2 Mini splits for the water plant building and the arsenic unit.

- b. Finance City Secretary, Catherine Long reported all the industrial agreement money was in, and that she will be moving money over to Texas Class.
