NEW BUSINESS – Discussion and Possible Action may be taken on the following:

a. Raunel Reynoso _ Remodel application at 2431 Main Street

Mrs. Reynoso was present and stated that they wanted to turn the old store into a barndominium. Mayor Bogue stated that they would have to get with the City Secretary to set up a inspection of the building before they could start. And as long as the inspector finds it ok to do that the city has no problem with them doing it.

b. Smith Nursery – Request to have retail plan sales along the with existing wholesale sales at 1119 CR 192.

Smith Nursery was not present, however, Council just wanted to get it on appropriate record that it was approved, as they could not vote on it last month.

-Council Member Marie Middleton made a motion to approve the retail and wholesale selling of plants at Smith Nursery located at 1119 CR 192.

c. Mark and Kriby Vanderslice – Drainage issues located a 3200 St. Anne Street.

Mr. and Mrs. Vanderslice were not present, neither was Brandon Middleton, City of Liverpool's Drainage Commissioner; however, Brandon sent a report to City Secretary, Catherine Long, which stated, "I went and looked at the ditch they said wasn't draining. Yes, there was work done by someone on the Riverhaven side. For how wet it has been the job didn't look that bad and may wear itself in. We just need to keep an eye on it. If we had the county come in now to fix it with all the rain it would do more damage than good". Mayor Bogue, and the Council agreed that it just needs to be watched.

They will put in a new septic and a new water tap. The home will be a new 2025 Double wide. He questioned if they could get a variance on the full slab and just have runners put in, Council agreed that they could not deviate from the ordinance. He questioned the driveway. Chris Duncan stated that he would look at the ordinance again and send him more information.
