OLD BUSINESS –Discussion and possible action may be taken on the following items:

- a. Stripping bid for CR 171

Mayor Matheny stated that he feels this needs to be done as soon as possible, because it's a liability on the City. The road is dark and there are no lines to show where the edge or the middle of the road is. He stated that He spoke to another stripping company and that their bid would have been \$15,000.00. And that he feels that it's important to not push this back until January to get more bids, that it went through procurement already, and that bid packets went out to local companies, and the only one that responded was America's Best Stripping. City Secretary Catherine Long stated that she included in the council packets the bill from when CR 192 was stripped in 2020 and cost the City \$17,000. And that it equaled out to .61 cents per leaner foot for CR 192, and that it bid for CR 171 equals out to .70 cents per leaner foot. Council members Marie Middleton, Philip Loving, Arthur Fuhrmann, and Greg Norman agreed that it needs to be done, and

to move forward with America's Best Stripping. Council Member Johnnie Tauber questioned if anyone knew anything about the company. City Secretary, Catherine Long stated that the company was a big company with multiple offices in different cities in the Country, but other than that no. He asked about reaching out to the Pearland to see who they used. Mayor Matheny along with the other council members stated that they felt that the price was not bad on the bid from America's Best Stripping, and that the road needs to be done sooner rather than later.

- Motion was made by Council Member Gregory Norman award the job to America's Best Stripping

- Council Members Philip Loving and Arthur Fuhrmann Approved.
- Council Member Johnnie Tauber obtained.


